
We met with Mr. Pierre Reid, MNA for Orford and will meet with Health Minister Mr. Réjean Hébert, MNA for Saint-François. There is no doubt that their support will be an asset in reaching our objectives. The MRC development agents and the Régie du Parc régional Massawippi will also be supporting us in our search for financial aid programs. #### **MONT HATLEY ZONING**

By adopting by-law 2013-09, Council has allowed for the residential development of part of the old Montjoye domain located near Horsefall road. Council wishes to conserve and consolidate the recreation zone which now hosts the new Parc du Mont Hatley tube sliding center.

The adoption of this by-law also allows the functions necessary for the establishment of a municipal administrative and community center to be located at 4765 Capelton road.

### FOLLOW-UP ON COUNCIL MEETINGS

### IN DECEMBER, COUNCIL:

- renewed its agreement with the Orford arts center for the yearly concert
- voted a resolution to demand that the provincial police build a station in the MRC Memphremagog region
- chose to renew the property assessment role for another three (3) years
- adopted the 2014 municipal budget and taxes

#### IN JANUARY, COUNCIL:

- adopted by-law 2014-02 concerning the code of ethics for elected council members
- demanded that any residential project

in the Horsefall road sector not use Horsefall road as an access to the new development

- authorized the signature of an agreement for the use of the kitchen in the new municipal building located at 4765 Capelton road

### IN FEBRUARY, COUNCIL:

- gave a mandate to the architect firm ADSP for the transformation of the building located at 4765 Capelton road.
- adopted a series of zoning by-laws
- gave notice that a by-law will be voted to change the speed limit on Sherbrooke road from 90 km/h to 70 km/h



#### **MUNICIPAL INFOS**

#### BUDGET

For the sixth year in a row, Canton de Hatley property owners will once more see their tax rates decrease. In fairness, in some years it was the property assessment that increased. This year, the tax rate has been reduced by between 2% and 3%; there is no increase in property assessments.

In 2013, the tax bill for a \$300,000 property was about \$2,018. In 2014, the same property will have a tax bill of about \$1,965.

The total 2014 budget is \$4,014,160. Of this amount more than a third of the budget, i.e. \$1,513,230, is for roads.



### PROPERTY ASSESSMENTS RENEWED FOR THREE YEARS



The current assessment role of property values in effect for the years 2012-2013-2014 is renewed for another three years, i.e. 2015-2016-2017. This means that property values will remain the same except, of course, in cases of increases due to improvements (renovations, additions, etc.)

The municipality has the possibility to renew a property assessment role if the preceding assessment role has been adjusted to be as close as possible to real values. This means there will be adjustments for the following assessment role period of 2018-2019-2020.

#### **SEPTIC TANK EMPTYING**

This year, the municipality will be emptying all septic tanks on its territory. This will take place starting in May and will end in August, and about 10 days ahead of time, home owners will be advised of the exact date.



The municipality has supervised the emptying of tanks since 2004. This year, the work will be handled by Beauregard fosses septiques. As in previous years, the tanks will be cleaned using Juggler technology that allows for the separation of solid and liquid waste. The liquid is returned to the tank at the end of the process,

# IMPORTANT CHANGES CONCERNING THE ZONING BY-LAWS

A public consultation will be held at the Lucien-Vachon hall, 3115 chemin Capelton, North Hatley, on February 27 at 7 p.m.

#### By-law 2014-03 -General land use plan

- ➤ Replace the general land use and main characteristic plans by using the current lot numbers.
- The allotted areas have been redefined in accordance with the regional zoning which has been redefined to allow for residential preauthorizations obtained by the Commission de la protection agricole du Québec in green zones (agricultural zones).

#### By-law 2014-04 - Zoning

- Replace the zoning plans by using the current lot numbers
- > Zones have been redefined in accordance with regional zoning and the general land use plan. This has

changed the allowed property uses of certain areas. Also, the new «ld» and «ldr» zones are shown and are the sectors where the Commission de la protection agricole du Ouébec has decreed preauthorizations for single dwelling homes. Of course these preauthorizations have specific implementation conditions. These conditions are detailed in the by-law. The agro-forestry zones have been subdivided into two categories, type 1 and type 2 to allow for preauthorizations for single dwelling homes on existing properties (January 19 2011) having an area of at least 5 hectares (agro-forestry zone type 1) and 10 hectares (agro-forestry zone type 2). Of course these preauthorizations have specific implementation conditions. These conditions are detailed in the by-law (maximum area, separation distance from agricultural activities, well location, ...)

- > Vegetation maintenance and the control of invasive species provided for in the project;
- Secondary construction (gallery and terrace) is authorized in the flood-risk area (max 20 m²) under certain conditions;
- Restrictions added in the various sectors identified for forest exploitation.

#### By-law 2014-05 - Lot subdivision

- ➤ For the new «ld» and «ldr» zones, minimum lot areas are defined;
- Include measures concerning coownership;
- ➤ Include measures to take into account the requirements of distinct lots for purposes of registration in a renovated area (land registry) for a transaction, even when the dimensions do not respect the minimums, as long as there is to be subsequent regrouping of land.

### By-law 2014-06 - Permits and certificates

➤ To ensure that zoning standards are respected, the by-law is changed to include the required document when requesting a permit in the new type 1 and 2 agro-forestry zones and the new «ld» and «ldr» zones.

### By-law 2014-07 - Architectural integration and implementation

➤ Changes are technical with the objective of simply changing the references to zones that have been changed in the zoning plan. The object is to maintain the reach of the by-law.

### End of season tube sliding special!



### New water treatment plant in operation this year

The construction of the new water treatment plant located in North Hatley is progressing as planned and most of the work will be completed in February 2014. The plant should be in service in July 2014.

The Régie Intermunicipale des Eaux Massawippi will be completing the necessary upgrades to many sectors of the aqueduct in the Canton de Hatley and in North Hatley village and the connection of the Hatley Acres section in Canton de Hatley.

If everything goes as planned, residents connected to the aqueduct should have access to quality water in sufficient quantity by the fall of 2014.

What you witness and report allows the police to better target interventions and respond more quickly.

### WHY HAVE YOUR PET SPAYED OR NEUTERED

Few people know it but it's the truth: a pair of cats can create **up to 20 000 descendants in four years** and a pair of dogs, **up to 4 000 in seven years**. This multiplication can become exponential and, nowadays, a litter is often one too many.

Over the years this situation has created an important population surplus in North America and considering its extent, many of these animals never find a home.



To end this problem, and at the same time improve the lives of thousands of animals left to fend for themselves, there is a simple solution that all pet owners have access to:

sterilisation.

Sterilisation avoids the great difficulty of finding a new home for a pet's offspring and it improves their quality of life.

### ALLISON BENNETT, A FRIEND TO MAN'S BEST FRIEND



For the last 25 years, Allison Bennett's days has been attuned to the rhythm of the dogs and cats under her care. At 7 a.m. it's a short walk on the grounds for all the dogs or, on occasion, in one of the outdoor pens. That is followed by the first meal of the day and the dispensing of medication to some. While the dogs are outside, it's time to clean the indoor pens. At noon, it's time for another short walk. At the end of the afternoon, some dogs will spend a bit of time in the large outdoor exercise pens. Dinner time is at 6 p.m. and then the dogs go out for a last time at 8 p.m. Two part-time employees, Susan Bennett and Julie Langlois, help out at the kennel.

After studying Animal Health Technology at Vanier College, in 1988 Ms. Bennett began working with animals on McKay street in North Hatley. At first, it was mostly a grooming service accompanied by a small boarding service.

But her passion for animals dates back to long before it became a business. As a child she loved to save and take care of a variety of animals, which she says jokingly "drove her parents crazy". In 1995, she moved to the present site located at 4640 chemin Capelton in Canton de Hatley. She has up to 45 dogs in peak periods, not counting the space reserved for cats. On average, about 15 to 18 dogs are boarding there on week days and about 25 on weekends.

Over the years, Ms. Bennett's kennel has served as an emergency shelter for the SPA and also in cooperation with the North Hatley fire department during the ice storms of 1998 and 2013 and the Lac Mégantic tragedy.

According to Ms. Bennett, perceptions have changed over the years. More and more, people consider their animals as family members. They want them to be happy and well taken care of in their

absence. There is a strong demand for her boarding service. If her kennel, appropriately named *Warm Hearts and Wet Noses*, knows such success it's simply by word of mouth and because of the many long-time return customers.
