and we are glad to see that things went well and met people's expectations. Thank you for your supportive comments.


With the warm season come cyclists. Our municipality sees thousands of cyclists passing through each year. Whether it be via the bike path or different roads, they are numerous in the summer. The MRC Memphrémagog, the regional government, has recognized that this activity could be an important economic contributor to our beautiful region. Our scenery, our lakes and roads are important factors of attraction to this clientele. The regional government is working on a marketing project to promote this activity. 
RURAL MAILBOXES

Mailbox installation in rural areas are often a constraint for contractors especially for winter road maintenance. To respond to this problem the municipality adopted, in 2005, the same standard as the Transport ministry for rural mailboxes.

The front of the box should be at least 5, 25 m (17'3") from the center of the road and 0,2 to 0,3 m (8-12") from the outer limit of the roadside shoulder as illustrated below. The bottom of the opening should be at 1,05 to 1,15 m (42-25") above ground.

The municipality will not require its citizen to relocate their mailboxes with the new norms. However, should your mailbox need to be replaced or relocated, then this will have to be done in conformity with new norms.

The municipality and contractors, will not be responsible for any damage



caused to any mailboxes that are not installed to this standard. Only claims for damaged mailboxes which would be installed according to these standards

will be admissible.

A RAIN BARREL IS A CONCRETE TOOL TO SAVE WATER

During summer, drinking water is a precious ressource often used for uses that don't require potable water. Rain barrels allow us to reduce the

demand on municipal water treatment or individuasl wells by providing water for gardening and outdoor cleaning.

A 200 litre barrel can save, on average, 4800 litres of water per summer.

MARCH 2017 COUNCIL MEETING

1. Adoption of by-law no. 2017-04

Council adopted the second project of by-law no. 2017-04 modifying zoning by-law 2000-08. The object of the by-law is:

- Allow «personal services» use in the RT-3 zonae but only as a secondary use to commercial lodging;
- Allow the micro-brewery restaurant use in the RT-9 zone;
- Allow a bed and breakfast use in the RV-5 zone

2. Adoption of by-law 2017-03

Council adopted by-law 2017-03 determining the protection radius for drinking water sources from hydrocarbon exploration and exploitation in the municipality

3. Construction authorized, 104, rue des Méandres and 4630, chemin de Capelton

Council accepted the request to build at 104, rue des Méandres and 4630, chemin de Capelton. By-law 2000-13 concerning architectural integration and implementation apply for this project.

4. Sale for unpaid taxes

Council approved the list of properties to be sold for unpaid taxes: lots 4029688 and 4029816.

5. RCGT nominated for 2017-2018 financial statements

Council nominated the firm Raymond Chabot Grant Thornton S.E.N.C.R.L. for professional accounting service for the years 2017 and 2018.

6. Route Verte subsidy program

Council approved the 2017 Route Verte (bike path) maintenance report prepared by the city of Sherbrooke.

7. Support program for school break

Council authorized Mrs Liane Breton, director, to sign a financial aid agreement as part of the *Programme de soutien des projets de garde pendant la relâche scolaire et la période estivale 2017*. The goal is to finance an extra week for summer day camp.

8. Urban planning committee

Council named the following members to the urban planning committee for a mandate ending March 6, 2019: Mr Vincent Fontaine, councillor, Mrs Geneviève Vallières, citizen, Mr François Carpentier, citizen.

9. Substitute mayor named

Council named Mr Jacques Bogenez as substitute mayor form April 1st to November 5th 2017.

10. Tree tunnel on Lake road

Council approved the report from Emilio lembo, forest inspector and accepts to protect the trees specified in the report as part of a planned tree tunnel for Lake road.

APRIL 2017 COUNCIL MEETING

1. Adoption of by-law 2017

Council adopted by-law 2017-04 to modify zoning by-law 2000-08. The object of the by-law is:

- Allow «personal services» use in the RT-3 zonae but only as a secondary use to commercial lodging;

2. April is daffodil month

Council decreed that April is daffodil month. Council encourages the population to generously support the cause of the Canadian cancer society.

3. Nomination of Mrs Émilie Béland Deland

Council has named Émilie Béland Deland as assistant building and environment inspector for the period of May 24 to August 12 2017.

4. Dunant road acquisition

Council authorized the acquisition of lot 3 746 456 to standardize the width of Dunant road.

5. Lake patrol nominated for 2017

Council named the Massawippi lake patrol for 2017 : Sabrina Asselin-Généreux, Isaac Martin, Anthony Leroux, Antoine Lefebvre, Audrey Boulanger and Guillaume Dubé. They are charge with applying the following by-laws:

- Vessel Operation Restriction Regulations
- Small Vessel Regulations
- Competency of Operators of Pleasure Craft Regulations
- Private Buoy Regulations
- By-law concerning public nuisance and preventing zebra mussels

6. 5080 Capelton road

The municipality will contact the MERN (Ministère de l'Énergie et des ressources naturelles) to obtain details concerning the hill behind 5080 Capelton road as the owner would like to see it removed.

7. Fuller road signs

The municipality will ask public works to check about installing *No parking signs* on Fuller road near the bridge.

8. Canton de Hatley choir

The municipality will provide a \$1250 subsidy to the Canton de hatley choir. The choir will offer two concerts in 2017.

9. Large item collection

Council authorized a single large item collection on May 25 by Sani Estrie for \$2256.

10. Connect to innovate

Council supports the Cogeco company in its request for financial aid from the Connect to innovate federal program and the Québec branché program.

11. Construction requests

Council has accepted construction requests for 186, rue des Méandres, 34-36, rue des Méandres and 194, rue des Méandres. By-law 2000-13 concerning architectural integration and implementation applies to these projects.

Did you know that Public health recommends that you test your well water on a regular basis.

- Bacterial analysis: twice a year, in the Spring and Fall
- Nitrates and nitrites (in agricultural zones): once or twice a year
- Arsenic and other contaminants: at least once

PROTECT YOURSELF AND YOUR DOG AGAINST LYME DISEASE

You are the proud owner of a dog? If so, **Lyme disease concerns you** as it affects dogs but also **humans**.



What is Lyme disease?

It is a disease transmitted by the generally painless bite of the black legged tick (deer tick) infected with the *Borrelia burgdorferi* bacteria. It can affect dogs and humans and it can lead to complications if it is not detected in time.

Are you at risk?

Ticks live in:

- Grass;
- Brushs;
- Shrubs and forests (especially along paths)

To determine of you or your dog are at risk, answer the following questions:

- Does your dog have access to a park or other areas with grass or forest?
- Do you bring your dog to the cabin, camping or hiking?



- Does your dog come with you to picknicks, to the beach or walking in the forest?
- Have you ever seen a tick on your dog?

If you answered YES to one of these questions, talk to your veteranarian about how to protect your dog from Lyme disease.
